#### **EMERGENCY MEDICAL SERVICES - 1 POSITION EMT- Intermediate or Paramedic Credentialed**

**Stokes County currently has one (1) position available for Emergency Medical Services  
EMT –Intermediate or EMT-Paramedic Credentialed**

**EMT-INTERMEDIATE** – Credentialed by the North Carolina Medical Board as an Intermediate Emergency Medical Technician – Possess a valid driver's license. Performs intermediate level life support, stabilization procedures, and emergency medical care in the Emergency Medical Services unit of the County. An employee in this class is responsible for providing intermediate level of life support and medical emergency treatments to patients at the accident or illness scenes and during transport to medical facilities. May serve as a crewmember on an advanced life support unit under the direction of an EMT-Paramedic.

Education: Completion of high school and some experience as an emergency medical technician or an equivalent combination of education and experience.

Hiring Salary: **\$25,019.00** annually plus overtime (Salary commensurate with experience)

**EMT-PARAMEDIC** – Credentialed by the North Carolina Medical Board as an Emergency Medical Technician-Paramedic – Possess a valid driver's license. Performs paramedic level life support work in the Emergency Medical Services unit of the County. An employee in this class performs professional advanced life support work in operating an approved mobile medical unit, rescuing victims and performing advanced emergency care including the administration of life sustaining treatment to patients on-site and while en route to hospital. Work involves responding to the scene of emergency and non-emergency calls, applying necessary medical treatment to sick or injured persons, and transporting persons to a medical facility. Employee serves as a member of an ambulance crew and is responsible for the medical care administered to the patient.

Education: Completion of high school and 1 to 2 years of experience in advanced emergency medical service work; or an equivalent combination of education and experience.

Hiring Salary: **\$29,269.00** annually plus overtime (Salary commensurate with experience)
